

### **DISTRICT AND DEPARTMENT COMPETITIVENESS INDEX - DDCI**

CHỈ SỐ NĂNG LỰC CANH TRANH CẤP HUYỀN VÀ SỞ NGÀNH

The District and Department Competitiveness Index (DDCI) is developed with a view to measuring the quality of economic governance of local governments at districts and provinces — the administrative levels which have direct interaction with economic entities like household businesses, enterprises, cooperatives and investors.

DDCI was first developed in Vietnam in 2013 by Economica Vietnam and Lao Cai Provincial People's Committee. For the first time, the indicator framework for assessing economic governance at the local level was introduced. In Lao Cai, DDCI has been continuously implemented in recent years and has become an important tool for provincial governance, effectively supporting the improvement of the business environment and competitiveness of the province. DDCI also contributes tremendously to the effort of Lao Cai in maintaining high ranks in the Provincial Competitiveness Index (PCI) in recent years.

DDCI has been since then rolled out to many other provinces such as Vinh Phuc, Kien Giang, Bac Giang, Tuyen Quang, Quang Ninh, Bac Ninh, Yen Bai, Cao Bang, Hue. Son La. Quang Nam and Dak Nong... Again. DDCI has



continuously strengthened in recent years. In particular, DDCI has become one of the measures adopted by many provinces in implementing the Government Resolution No. 19-2018/NQ-CP on solutions to improve the business environment and improve national competitiveness and the Resolution No.02/NQ-CP on measures and actions to improve business environment and national competitiveness in 2019 with vision to 2021.



After six years of implementation, and based on the implementation experience of many provinces, Economica Vietnam has further improved the approach and methodology of DDCI. A totally new version of DDCI has been introduced, passing a stringent testing and appraisal process by participating provinces and by leading economic governance experts and managers in Vietnam. This totally new methodology, and innovative, advanced and modern methods of implementation is now being applied in the implementation of DDCI 2019 in a number of provinces.


### **Economic Governance Principles in DDCI**

DDCI is meant to promote the principles of good economic governance at province and district levels. Therefore, DDCI is based on the perception of the businesses on the capacity and adeptness of government agencies, specifically those at department and district levels in economic governance. The reality in Vietnam and international practice indicate that key principles for good economic governance at district and department levels in Vietnam can be summarized in the box below.

#### **Economic Governance Principles in DDCI**

- 1. Effective implementation of policy and regulation in the best benefit of businesses
- 2. Continuous improvement of public services.
- 3. Information transparency and non-discriminatory treatment.
- 4. Leadership being accountable, responsive, proactive, pro-business and action-oriented.
- 5. Regular, responsible business dialogues and high sense of accountability.
- 6. Easy, convenient and low-cost market entry.
- 7. Easy and transparent accessibility to land and business premises.
- 8. Effective business licensing and inspection.
- 9. Simple, convenient, transparent and fair tax procedures.
- 10. Vigorously improved administrative procedures and effective one-stop-shop.
- 11. Practical and effective business support services with easy and non-discriminatory access.
- 12. Informal costs being curbed.
- 13. Inclusive growth, social dimensions and gender equality being well-considered.
- 14. Environment and ecological sustainability are duly integrated in governance.

DDCI is therefore a mirror that reflects exactly the perception of the local business community on all dimensions of economic governance of local authorities. DDCI is also a barometer that measures the satisfaction on the business environment, and the sentiment on business prospects in the context of the district and provincial business environment.

#### Indicators of DDCI

10 indicators used in DDCI to measure economic governance of distric governments:

- Market entry.
- 2. Accessibility to land and business premise.
- 3. Quality of public service in licensing and efficiency in inspection.
- 4. Proactivity and dynamism of district leadership.
- 5. Efficiency of public and private dialogues and accountability.
- 6. Information transparency and fair treatment.
- 7. Effectiveness in administrative procedure reforms, public services and of district one-stop-shop.
- 8. Effectiveness of business support services.
- 9. Informal costs.
- 10. Public order and security in support of a safe business environment.

In addtion, DDCI district can also include the following extended indicators: (i) Application of information technology and e-gov in economic governance; (ii) Cost and time in complying with administrative procedures and implementing public services; (iii) Effectiveness of tax procedures; and (iv) Sustainable and inclusive development in economic governance.

5 indicators used in DDCI to measure economic governance of provincial governmental departments and agencies:

- Effectiveness in implementation of legal documents, planning documents and plans.
- 2. Quality of public services.
- 3. Information transparency and fair treatment.
- 4. Proactivity and accountability of department leadership.
- 5. Informal costs.

In addtion, DDCI of provincial departments t can also include the following extended indicators: (i) Application of information technology and e-gov in economic governance; (ii) Cost and time in complying administrative procedures implementing public services; and (iii) Sustainable and inclusive development in economic governance
